Placement 2011 kicked off with industry giants vying to pick up some of the best talents in the country. BIM saw a host of top notch firms making their presence this placement season.





Finance students benefitted from the buoyant mood of the economy with firms like CRISIL, ICRA, Irevna, SBI Caps, CTS UBS, SBI Bank, EXIM Bank and HDFC Bank making their presence felt. The financial services industry, which has always recruited in good numbers from BIM, has offered some of the most coveted profiles this season as well.

Students were offered roles in Equity Research, Fixed Income Securities and Derivate Analysis, Wealth Management, Project Finance, and Risk management to name a few.

Impressed with our students' performance, companies have gone to the extent of carving out new profiles like Strategy Research & Intelligence.





Consultancy firms like Deloitte and iMacs have offered roles in Strategy & Operations and Corporate Advisory functions. Marketing firms, spurred by the optimism in the economy, made a beeline to recruit the brightest of minds.

Apart from the regular recruiters like Wipro Consumer Care, Asian paints, IMRB, CavinKare and HDFC Life, this year saw the addition of heavy weights like Citibank, Murugappa group, Feedback Consulting, HDFC Bank, IDBI Bank etc. Some of the roles offered include Area Sales Manager, Business Development Manager, Research Manager and Relationship Manager. Students were offered profiles in both B2B and B2C segment.



The surge in the IT industry was clearly seen in the heavy demand for systems profile students. Students with a prior IT work-ex had an edge over the rest. Systems ruled the roost in the placement process with premier IT firms like Accenture, Google, Infosys, HCL, Ramco Systems and iGate picking up students for Project Management, ERP Consulting, Business Analyst, AdWords Associate roles. Students were offered Senior & Middle Management positions for IT solutions & Mobilization profiles.





This year also saw PSUs like SBI Bank and Balmer Lawrie & Co offering IT and Online marketing profile. Operations saw a tremendous push and the Institute reaped rich dividends in form of top notch firms like Accenture Consulting and Thomas Cook hiring this season. BIM being associated with BHEL, which excels in the area of operations, has always produced good talents in the field of operations. Our students have consistently met the confidence reposed by the recruiters.



HR at BIM has been witnessing an improving trend year on year. This year, core HR functional roles like Organisational Development, Training & Development and Recruitment were offered by companies like Murugappa Group, UCAL Systems, to name a few. Students were also offered HR consultant roles in top IT firms.
